ASPA Credentialing Application Service For additional plans, direct contracting and hospitals, ASPA offers an application service (at additional charge) to cover all your credentialing needs and application requirements freeing your staff to handle other areas of your practice. The following rates can be negotiated based on the size of the group and/or number of plans or facilities the group will need to be credentialed with.

Schedule of Fee's per Provider per Year:

Initial Arizona Fees:

- \$3000.00 per new physician for initial year of service
- \$1750.00 per new PA/NP for initial year of service
- \$1500.00 per new Registered Dietician for initial year of service
- \$1500.00 per new PT for initial year of service

Initial Out of State Fees:

- \$4000.00 per new physician for initial year of service
- \$2250.00 per new PA/NP for initial year of service
- \$2000.00 per new PT for initial year of service

Each Year There After:

- \$1000.00 per physician per year for each year thereafter
- \$750.00 per PA/NP per year for each year thereafter
- \$500.00 per Registered Dietician
- \$500.00 per PT per year for each year thereafter

Credentialing Services for facilities such as Urgent Care or Diagnostic Imaging will be reviewed and quoted independently.
